This data was received from our Freedom of Information Act Request to the UKIPO for the top filers of 2018, this statement explains why some of the data has been redacted.

“

We note that the ‘Top Filers’ list for 2017 produced by CITMA appears to include named individuals as well as law firms, though the exact description of some members of the list (companies, partnerships, individual practitioners etc.) is not always clear.

You will notice that we have redacted from the list any names that appear to be those of private individuals, which are exempt from disclosure under s.40(2) of the Freedom of Information Act 2000. S.40(2)(a) exempts personal information if disclosure would contravene any of the data protection principles, in this instance the first, which requires that personal information be processed lawfully, fairly and in a transparent manner. In the absence of consent to disclosure from the individuals concerned we have decided to withhold their identities.

Please note also that the list is based upon records of representatives as at 31 December 2018. We cannot identify all the representatives who filed applications as we don’t keep historic versions following any changes of representatives after filing, so we have looked at every case filed in 2018, identified who the current agent is, and counted the number of applications per agent.
